## **Public Mutual Declares Distributions of RM217 Million for 2 Funds**

Public Bank's wholly-owned subsidiary, Public Mutual, declared distributions amounting to more than RM217 million for 2 funds. The total gross distributions declared for the financial year ended 31 March 2016 are as follows:

Public Aggressive Growth Fund	2.00 sen per unit
Public Regular Savings Fund	2.35 sen per unit

Public Regular Savings Fund is open for EPF Members Investment Scheme. Both of the above funds are distributed by Public Mutual's unit trust consultants.
