The Manager has proposed that the Investment Policy and Strategy of Public Regular Savings Fund ("Fund") be modified to enable the Fund to invest up to 25% of its net asset value in foreign markets. Please refer to the **Explanatory Notes on page 4** for the rationale on the proposed change of the Investment Policy and Strategy of the Fund.

Please be informed that unless otherwise expressly stated, the words and expressions used herein shall have the same meaning as ascribed to them in the Deed of the Fund.

The purpose of the Meeting is to consider and, if thought fit, approve the following proposed amendments and modifications relating to the Investment Policy and Strategy of the Fund as follows:-

Resolution 1

That the Investment Policy and Strategy of the Fund be amended and modified to read as follows:-

Asset Allocation

"Up to 25% of the Fund's net asset value may be invested in foreign assets."

Location of Assets

- Malaysia
- Up to 25% of net asset value may be invested in foreign markets which include China, Singapore, Hong Kong, Thailand, South Korea, Indonesia, Taiwan, United States of America and any other permitted markets where the regulatory authority is an ordinary or associate member of the International Organization of Securities Commissions."

Resolution 2

Subject to Resolution 1 being duly approved, that the Manager and Trustee of the Fund be and are hereby authorised, for the purposes of effecting the aforesaid Resolution, to execute a Supplemental Deed and to do all acts, deeds and things necessary to give full effect to the said Resolution, including any consequential modifications, as the Manager and Trustee may in its absolute discretion deem fit, on a date to be decided at the absolute discretion of the Manager in consultation with the Trustee.

The quorum for the Unitholders' meeting is five (5) Unitholders. Resolutions 1 and 2 must be approved by a simple majority of all the Unitholders voting at the meeting.

Please note that "Unitholders" are those whose names appear on the register of the Fund.

EXPLANATORY NOTES

MODIFICATION OF INVESTMENT POLICY AND STRATEGY OF PUBLIC REGULAR SAVINGS FUND: RATIONALE

Rationale for Resolution 1 – Change of Fund's Investment Policy and Strategy

Given the increasing fund size, it is proposed to include a foreign investment limit of up to 25% of net asset value for the Fund. The proposed change would provide the Fund with a greater diversification of stocks and markets.
