1-Year Fund Performance Review

PSF registered a total return of +15.73% for the financial year ended 31 December 2024 in comparison to its benchmark's return of +12.90% over the same period.

Notes:

- * The figure shown is for the period since the fund's commencement (27 April 1981).
- ** Prior to 6 July 2009, the fund's benchmark was the Kuala Lumpur Composite Index (KLCI).

Effective from 6 July 2009, Bursa Malaysia replaced the KLCI with the FTSE Bursa Malaysia KLCI (FBM KLCI). As such, the FBM KLCI has been adopted as the new benchmark for the fund. The FBM KLCI comprises the 30 largest companies by full market capitalisation listed on the Bursa Malaysia Main Market.
