# **1-Year Fund Performance Review**

PINDOSF registered a total return of -16.38% for the financial year ended 31 August 2024 in comparison to its benchmark's return of -2.83% over the same period.

Notes:

- \* The figure shown is for the period since the fund's commencement (21 September 2010).
- \*\* Prior to 30 April 2011, the benchmark of the fund was the Jakarta Composite Index.

From 30 April 2011 to 1 January 2024, the fund's benchmark has been replaced with the Jakarta LQ-45 Index which comprises the 45 largest companies by market capitalisation listed on the Indonesia Stock Exchange.

Effective from 2 January 2024, the fund's benchmark has been replaced with S&P Indonesia LargeMidCap 10% Capped Index as this index is a better representative of the performance of the Indonesian market.

The calculation of the above returns is based on NAV-to-NAV basis, and is sourced from Lipper.

Average annual returns of the fund are derived by dividing the total returns of the fund with the number of years under review.

Commencement date is the last day of the initial offer period.

For the financial year ended 2024, the fund's PTR subsequently increased to 1.07 times due to a higher level of rebalancing activities undertaken by the fund.

# Cooling-off right

- The refund will be paid within 7 business days from the date of exercise of this right.
- The refund for every unit held will be the sum of the price of a unit (i.e. original price on the day the units were purchased or market price at the point of exercise of the cooling-off right, whichever is lower) and the sales charge imposed (and any applicable taxes and/or duties, if any) on the day the units were purchased.
